# GENERAL TERMS AND CONDITIONS OF BOOKING

The management and the team of Camping de la Plage welcome you.  
Please read the following conditions carefully.

1 - The present general terms govern automatically all the sales actual on the site: [www.campingdelaplage.com](http://www.campingdelaplage.com). They form integral part of any contract concluded between the camp-site and its customers.

1.1 - Each customer admits having taken knowledge of these general terms prior to any reservation of a stay, for itself and any person taking part in the stay.

1.2 - In accordance with the law in force, the present conditions are put at the disposal of any customer on a purely data-processing basis prior to the concluding of any sale contract of stays. They can be obtained on request written addressed to the head office of the establishment.

1.3 - The price of the stays is indicated in euros, VAT included. The customer's attention is drawn to the fact that the tourist tax is not included in the price.

2 - Complete, sign and post this leasing agreement to us with your deposit i.e. 25% of the cost of the stay + 30€ administrative expenses + insurance (optional) payable to SARL CAMPING DE LAPLAGE (no administrative expenses in off-peak seasons). We will only bank your deposit if we accept your booking.

2.1 - We will confirm your booking, if possible, once we have received your deposit and leasing agreement. The balance of the rent must be paid 30 days before the beginning of your stay. Your booking will be cancelled if this balance is not received in time.

3 - Tenants must arrive between 3.00 and 8.00pm and leave before 10.00pm on the day of departure. From May 29 to August 21, 2022 rentals run from Sunday to Sunday exclusively. **THE ANIMALS ARE NOT ALLOWED IN THE RENTALS.** Rental properties are equipped with crockery, pillows and duvets: you must bring your own sheets and pillow cases. All campers agree to comply with camp-site rules and regulations.

4 - Rental rates include electricity, water and gas, access to the swimming pool and events during the peak season.

5 - The day of your arrival a quantified inventory of the equipment of each hiring will be given to you. Any noted anomaly must be announced **the very same day.** It will be to you demanded **2 guarantees:** the first guarantee breaks of an amount of **350 €** (check or cash) which to you will be restored the day of your departure after inventory and deduction so necessary of the expenses of repairing and replacement of missing equipment, the second guarantee spares of an amount de **50 €** exclusively in cash will be retained if the housework of the hiring were not correctly done before the departure, the starting inventories, are done the very same day, during the opening hours of the reception. Any hiring is personal; it cannot be yielded or under rented.

6 - Any hiring not balanced in accordance with the general terms of sale will be cancelled. No reduction will be carried out in the event of delayed arrival or of early retirement.

7 - **SWIMMING POOL:** Opening of 9:00am to 7:30pm. The visitor admission charge does not give your guests the right to use the pool.  
**BATHING SLIPS OR BOXER SHORTS OBLIGATORY**

8 - If you cancel your booking you will still have to pay:

- Administrative expenses (if due)
- 25% of the total cost of your stay if you cancel more than 30 days before your stay.
- The whole cost of the stay if you cancel less than 30 days before your stay.
- If we cancel, we will reimburse you everything you have paid with the exception of cases of force majeure.
- Cancellations must always be notified by registered letter with recorded delivery. The postmark is proof of posting.

8.1 - We advise you to subscribe an insurance cancellation/interruption of stay (optional) This contract offers a warranty cancellation to you which makes it possible to obtain the refunding of the sums paid in the event of cancellation of your stay or early retirement under unquestionable condition (disease, accident...).  
**Rate Insurance Cancellation site Camp-site: 2,90 % of the amount of the benefit.**

8.2 - **This insurance must be subscribed at the time of your reservation.** The general terms of this insurance (*Methods, franknesses and application of the warranties*) are consultable first on our website.

9 - IMAGE rights: The operator reserves the right to use any photographic medium where the client may appear to his publications. The customer accepts the use that could be made, including on external communication media and waive any remuneration or compensation.

10 - Institutions under video surveillance. On-site video surveillance in accordance with the ministerial order No. 2011-86 and the Code for Homeland Security (art.) L223-1 L223-9 and 1-L251 L255-1) & (art.) R251-1 to R253-4).

11 - As the law requires it, you must adhere to our rules of procedure, deposited with the prefecture, displayed with our reception and whose specimen will be given to you on request.

12 - The camp-site declines any responsibility for the damage undergone by equipment for the camper-caravaneer which of its characteristic would be made; insurance for your equipment as regards civil responsibility is compulsory.

13 - The present general terms are subjected to the French right and any litigation relative to their application falls within the competence of the Court of Bankruptcy or the Bankruptcy court of Privas.

14 - Mediation and Consumer Disputes:

In accordance with the provisions of the Consumer Code concerning "the mediation process of consumer disputes", the customer has the right to use the mediation service offered by Camping De La Plage free of charge. The "consumer law" mediator thus proposed is CM2C.
